

## **Prize Draw Terms and Conditions**

1. The prize draw (the "Prize Draw") is open to people aged 18 and over who are IKCA donors and provide their Donor ID, full name, email address and mobile phone number.
2. Employees, Trustees or agencies of Imran Khan Cancer Appeal ("IKCA", "We") or their family members, or anyone else connected with the Prize Draw may not enter the Prize Draw.
3. Entrants into the Prize Draw shall be deemed to have accepted these Terms and Conditions.

6. IKCA accepts no responsibility for entries that are lost, delayed, misdirected or incomplete or cannot be delivered or entered for any technical or other reason. Proof of delivery of the entry is not proof of receipt by IKCA.
7. The closing date of the Prize Draw is 23:59 on 7th June 2019. Entries received outside this time period will not be considered.
8. Three winners will be chosen from a random draw of entries received in accordance with these Terms and Conditions. The draw will be performed by a random process which will take place by 14th June 2019.
9. The three winners will each receive an economy ticket, departure from London, UK, from an IKCA selected airport, airline and route, to Lahore, Pakistan, and accommodation at the Shaukat Khanum Hospital's Guest Accommodation at specific dates to be arranged by IKCA.
10. By submitting your personal information you agree to receive emails from IKCA containing offers and developments that we think may interest you. You will be given the opportunity to unsubscribe on every email that we send.
11. IKCA accepts no responsibility for any costs associated with the prize and not specifically included in the prize (including, without limitation, travel to and from the IKCA selected UK departure Airport and any food costs).
12. The winners will be notified by email or mobile phone on or before 20th June 2019 and must provide a postal address to claim their prize. If a winner does not respond to IKCA within 14 days of being notified by IKCA, then the winner's prize will be forfeited and IKCA shall be entitled to select another winner in accordance with the process described above (and that winner will have to respond to notification of their win within 14 days or else they will also forfeit their prize). If a winner rejects their prize or the entry is invalid or in breach of these Terms and Conditions, the winner's prize will be forfeited and IKCA shall be entitled to select another winner.
